## **Young Engineers Crawley Program Participant Agreement**

In consideration of the services of Young Engineers Crawley and its affiliated staff/volunteers provided to the participant(s), the parent or legal guardian acknowledges and agrees to the following:

### **1. ACKNOWLEDGMENT AND ASSUMPTION OF RISKS**

The safety of children in our program is the top priority of Young Engineers Crawley staff/volunteers. During class programs, instructors will ensure that the group is physically safe and comfortable. However, I, the Parent/Guardian, acknowledge and agree that there are many known and unknown dangers and risks associated with participation in class programs, and that some activities may be physically strenuous. I have had the opportunity to ask questions about the program activities and the risks of the program in which my child/children will participate. It is impossible to anticipate every activity in which my child/children will engage in. It is impossible to know or list every risk associated with every activity. Risks will depend on the program. Some, but not all, of the risks my child/children may encounter include, but are not limited to: minor cuts, bruises, and scrapes, improper or malfunctioning equipment; slipping and falling; physical contact with other participants; and other natural or man-made hazards, as well as the risk of serious injury or death. I acknowledge, agree, and understand the aforesaid dangers and risks associated with the program and notwithstanding such dangers and risks agree to provide permission for my child/children to participate in the Young Engineers Crawley learning program.

### **2. PERMISSION FOR FIRST AID AND OTHER MEDICAL TREATMENTS**

I acknowledge and agree that participating in activities can expose my child/children to risks and possible injuries. In the event of emergency, I hereby consent for my child/children to receive first aid treatment and medical treatment, including transportation to a doctor or hospital, which may be deemed advisable in the event of injury, accident and/or illness during the program. I hereby also give permission to Young Engineers Crawley staff/volunteers to assist in administering prescribed medications, such as epi-pens and inhalers, if the participants cannot administer it themselves.

### **3. LIABILITY RELEASE AND INDEMNITY AGREEMENT**

I hereby forever release, waive, and fully discharge Young Engineers Crawley, and each of its employees, volunteers, independent contractors, directors or related parties (collectively referred to as “the Released Parties”) from and agree not to pursue a claim or sue the Released Parties for any liability, claim, or expense in any way associated with my child/children’s enrollment or participation in the Young Engineers Crawley program or the use of any equipment. Neither I nor anyone acting on my child/children’s behalf will make a claim against the Released Parties as a result of any injury, illness, damage, death, or loss. This release includes any losses caused or alleged to be caused, in whole or in part, by the negligence, whether active or passive, of the Released Parties to the fullest extent allowed by law (but not for gross negligence) and includes claims for injury, property damage or loss, wrongful death, breach of contract, breach of any statutory duty or any other type of suit.

### **4. PHOTO AND VIDEO CONSENT**

I understand some activities will be recorded. If I have agreed/consented to give permission for Young Engineers Crawley and its staff/volunteers to take photos and videos of my child/children during class, all photos and videos taken will be shared with the registered family groups associated with the child/children and may be used for educational and promotional purposes in the future. I agree to the use of such photos and videos for any legitimate purpose by Young Engineers Crawley staff, volunteers, producers, sponsors, organisers, and assigners.

## **5. CANCELLATION AND REFUND POLICY**

For all programs:

- a. COURSE FEES ARE NON-REFUNDABLE
- b. Outdoor Sessions are subject to weather (ie. during inclement weather, students will have activities in classroom)

Refund policy due to personal cancellation:

1. For our course of regular weekly classes - Young Engineers Crawley requires 48 hour notice for personal cancellation in order to get credit - for a maximum of 2 (two) missed classes in the running course. We will give credit for missed classes which is valid only for payment against future classes in the next immediate course of regular weekly classes.
2. For all our Camps and Special Events - We don't offer a refund, credit or make-up classes for missed camps/workshops.

## **6. MAKE-UP CLASS POLICY**

In the event of unexpected cancellation by Young Engineers Crawley we will make arrangements for an appropriate make-up class.

## **7. SPECIAL CIRCUMSTANCES**

To ensure the health and safety of our instructors and students attending Young Engineers Crawley program, we ask families to disclose any specific physical, medical, emotional or educational needs of their child/children during the registration process. This will allow our Young Engineers Crawley team to provide proper, personalised support to your child when applicable and appropriate. Due to the nature of the class program and size of the groups, it may be difficult or unsafe for our instructors to support a specific child without any additional support or information. Young Engineers Crawley reserves the right to refuse admission to or dismiss a child who may not be acting appropriately or who may be causing major disruption to the class. This is to ensure that all children attending our program receive the same attention and learning opportunities needed to thrive for the duration of the program.
